The regularly scheduled Board meeting will immediately follow the special meeting.

**Adm.Cl.Cottone:** OK, we want to go into amending the 2017 Budget as it was previously approved at the December meeting.

**Resolution 2017 – 01** To amend the 2017 Budget pursuant to NJSA 40A:14-78.3 for the Fiscal Year January 1, 2017 to December 31, 2017. The Board desires to amend certain line items in the 2017 Budget. Anticipated Revenues - the fund balance utilized will go from \$300,000 to \$315,000. The amount to be raised by taxation will go from \$1,456,540 to \$1,441,540. We will send two certified copies of this Resolution to the Director of the Division of Local Government Services. So you will all vote on the amendment for the Budget.

**Resolution R-2-17** Regarding the Procedures for the Adoption of the Fire District Budget. Whereas, NJSA 40A:14-78.2 establishes certain procedures that must be followed by the Fire District's in the Adoption of the Budget. It therefore states:

- 1. That we introduced, had the first reading and approved the Budget.
- 2. That we set the time and place for the holding of the public hearing on the Budget.
- 3. The public hearing and second reading of the Budget was held not less than 28 days after the first reading and approval.
- 4. The adopted Budget is authorized to be advertised by publishing at least seven days prior to the annual Election.
- 5. The Resolution is adopted in compliance with NJSA 40A:14-78.2 et al.

**Resolution R-3-17** The adoption of the 2017 Budget for Fire District 6.

The Annual Budget as presented for adoption reflects total revenues of \$1,789,135 which includes amounts to be raised by taxation of \$1,441,540 and Total Appropriations of \$1,789,135.
